FAIR ENTRIES

ENTRY TAG PICK UP

Fair Office (Building 1) on July 16th or July 20th

Entry tags will be available for pick up on Saturday, July 16th from 10:00 AM to 3:00 PM or on Wednesday, July 20th from 11:00 AM to 7:30 PM at the fair office in building 1.

There are no tags for Dairy, Beef, Swine, Sheep, Goats, Horses and Dogs. Foods Revue, Cake Decorating, Clothing Revue and Shooting Sports tags will be available at the appropriate judging events.

Attach the tags to your projects before going to the judge.

Tear off your Claim Check from the bottom of the tag and fold the tag over your name. Save your Claim Checks! You will need them to pick up your projects on Sunday, July 24 to pick up your exhibits.



FAIR ENTRY CHANGES

Entries for the 2022 St. Croix County Fair have closed and no changes can be made unless it has to do with an animal illness. If you have an animal issue please contact the species department head for instructions on changing that entry.

FORGOT WHAT YOU ARE BRINGING?

If you no longer have your entry email confirmation and you have forgotten what you entered, follow the instructions below.

1. Go to www.FairEntry.com and select "Find your Fair" State map, pick Wisconsin
2. Scroll down to St. Croix County 2022
3. Sign in with 4H Online account the green tab or if you used a FairEntry account use the Blue Tab
4. Pick the account you are looking for.
5. In Completed Invoice, click "View"
6. Right click and choose "Print"

JUDGING AT THE FAIR

Judging is on July 20th 12:00 - 7:30

Judging times and locations for specific departments are listed below and in the Premium Book. Please expect some delays later in the day for conference judging on Saturday, July 16 and Wednesday, July 20. Plan your time so that you can get all your exhibits judged. If you are in line and it is getting close to the end of the judging time, let someone know that you have other exhibits to judge so we can make adjustments.



TYPES OF JUDGING

Conference Judging

Conference judging of certain fair projects is performed to help exhibitors learn the strengths and weaknesses of their project directly from the judge. They meet face-to-face with the judge, who learns more about the work the exhibitor put into the entry while the judge evaluates it. Exhibitors then receive a ribbon for the quality of the exhibit & knowledge of their project, as well as new information they can use to do better next year.

Danish Judging

The Danish system of judging provides more exhibitors a chance to receive a ribbon for their entries. Instead of placing only the best four exhibits and giving them a blue, red, white, or pink ribbon (like in Open Class) all entries are placed. All entries receive a premium and ribbon. The number of blue, red, white, and pink ribbons a judge hands out depends on the number of entries in the class. For example, if there are 8 entries in a class, up to 2 can receive a blue rating, up to 4 red ratings, up to 6 white ratings, and up to 8 pink ratings.

JUDGING AT THE FAIR



Judging is on July 20th 12:00 - 7:30

1. Get your exhibits judged

After obtaining your entry tags from the fair office, take your tagged exhibit to the designated area to get judged. Stand in the appropriate line and wait for your turn. When its your turn, you can get all of your projects in that department judged at the same time (you don't have to get back in line for each exhibit).

2. Talk to the judge

When talking to the judge introduce yourself (name, grade, and what club your in). Talk about your project. When the judge asks you a question about your project answer honestly. Please ask questions of the judge if you are not understanding.

3. Receive Feedback

If you've done your best work on your project, it's disappointing not to get the rating you were expecting. Just remember - the judge's opinion is simply one person's opinion. A different judge might have given you a different placing. But even if you don't agree with the judge, its worth paying attention to what he or she has to say about your project. You could get some great ideas for how to do better next time.

Here are some tips about feedback:

- Pay attention to what the judge liked instead of getting upset about what he or she didn't like. Even if there were some negative comments, there were probably just as many positive ones!
- Don't be nervous about face-to-face judging. The judge is truly interested in youth, otherwise he or she wouldn't be there. Relax so you can be your friendly, natural self when the judge meets with you. And if you don't understand something he or she says, be sure to say so.
- Think about how you can use the judge's feedback. What can you do differently if you intend to keep working on this kind of project? What will you want to do the same way?

4. Scan Exhibits

There are three locations where you can find a scanner station (4-H Building, Croix Court Tent, and Cloverbud Building). Once your items are judged take them to the scanner stations to get scanned and receive your ribbons.

5. Display Exhibits

Once your items are scanned and ribbons are attached take them to their designated display area. Please ask for assistance if you are unclear where to take your items.

There is NO early release of exhibits. All exhibits, animals, and decorations must stay in place until 4:00 on Sunday, July 24.

PICKING UP EXHIBITS

Sunday, July 24 after 4:00 PM

You can pick up your exhibits on Sunday, July 24 from 4:00 PM to 7:00 PM. You **MUST** bring your claim ticket with you when picking up any exhibits. Check out at the scanning station in each building.

If you can't make the Sunday time, you may pick up exhibits on Monday, July 25 from 9:00 AM to 11:00 AM. All large and fragile exhibits must be claimed. If exhibits are not picked up they will be thrown away. If you have a conflict, find someone who will pick up your exhibits with your claim tickets.

PREMIUM CHECKS

Premium checks will be given to your 4-H club leaders in the fall (typically October). Please cash them as soon as possible. They expire within 90 days. After December 31, 2022 you will need to present yourself to the fair board meeting and explain that you need a new check.

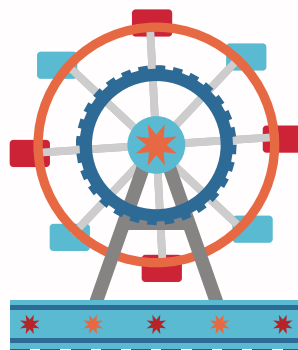

Judging will be based on creativity & originality, visual appeal, and uniqueness.

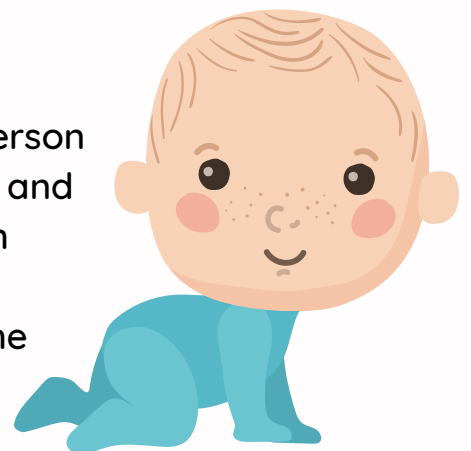

Exhibitors must present 3 servings of each entry. We highly recommend bringing entries in an unmarked to go box.

The product must be produced by a restaurant that resides within the limits of St. Croix County. All competitors must be an employee of the business that they are competing under.

Entries will be judged based on taste, appearance, and uniqueness. Each product will be judged by our panel of 3 judges. Judging order will be hamburgers, followed by ribs, and ending with pie.

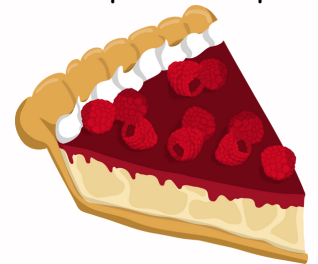
The top three entries in each product class will be honored with awards and the top of each product class will be honored with the title of "Best in St. Croix County".

TALENT SHOW

Croix Court Tent on Thursday @ 6:30 PM

1. Pre-registration is preferred by July 20, 2022. Registration form can be found [here](#).
2. All contestants must be amateurs, not professionals. The definition of professional is being a contestant who is paid to entertain.
3. No talent act shall exceed the time limit of three (3) minutes and set-up of one (1) minute, and tear down time of one (1) minute. Any talent exceeding the five (5) minute allotted time will be disqualified by the panel of judges
4. There will be four (4) Categories: Vocal, Dance, Instrumental, and Variety. Within the four (4) Categories there will be five (5) Age Divisions.
5. A mixture of age participants must enter the age bracket of the oldest participant.
6. Equipment provided includes: sound system, microphones, and keyboard. Participants need to provide any recording devices and appropriate cords/connectors.
7. First, second and third places will be awarded to each division and age group. First place will receive a cash prize of \$50; second place will receive \$25; and third place will receive \$10.
